SUBJECT: REGARDING REQUEST OF SCHOOL FOR ENHANCEMENT OF SECTIONS - REG.

Sir/Madam,

This is with reference to school application No.-IS-01841-2526 dt. on the subject cited above.

Sl. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 20 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 6 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
Sl. No.	CONDITIONS FOR COMPLIANCE
1	The total number of sections of Bal Vatika shall be restricted to 03 (01 section each for Bal Vatika-1, 2 & 3 respectively). The total number of sections from classes 1 to 10 shall be restricted to 20. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	Inspection committee has reported that Counsellor and Wellness Teacher has not been appointed by the school. As per clause 2.4.12 of the Affiliation Bye-laws, 2018, school shall appoint a person on full time basis for performing the duties of Counsellor and Wellness Teacher, within 03 months and submit compliance.
3	The school does not seem to have referred to RPwD Act and guidelines of the Board for CWSN toilets. School building is G+4, but, only two CwsN toilet for boys and one for girls are seen in the video. The School shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, indicating the floor number, as per norms of RPwD Act and guidelines of the Board within 3months and submit compliance on SARAS with videography.
4	Computer Lab is not sufficiently equipped. Less number of computers than as specified in SoP issued by the Board vide Circular No.11 dated 04.10.2022 have been seen in the inspection video. School has admitted that only 32 computer systems are available in the computer lab (video reference time 44:43). School shall increase the number of computers to minimum 40, within 03 months and submit the compliance with videography.
5	The library does not have separate reading area for staff/teachers. School shall make provision of separate reading area for teacher in the library as per board's SOP, within 3 months and submit compliance on SARAS with videography.
6	The school shall ensure the training of its teachers with CoE Ajmer within 3 months and submit the compliance.

In this connection, I am directed to convey approval of the Board to permit increase of sections in the school and subject to strict adherence to the other provisions of Affiliation and Examination Bye-Laws of the Board & appendix V of Affiliation Bye-Laws as well as the following specific conditions:

1. The school is permitted to run () total number of sections. In case of Senior Secondary level 1/3rd of the total sections permitted can be run in Class XI & XII.
2. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.

3. The school is required to renew Water & Health Sanitation, Building Safety and Fire Safety certificates on regular basis.
4. The school will ensure adequate teaching staff and other physical facilities in the school for the smooth functioning with its enrolment.
5. The school will adhere to Rule 14.12 of Affiliation Bye laws of the Board and maintain optimum strength of 40 students in a section.
6. This approval will be subject to final outcome of any legal case/ litigation and any other issues arising out of shifting of school or otherwise and CBSE shall not be responsible for any dispute/legal issue arising out of increase in sections.
7. The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye Laws.

“The school shall possess valid fire safety certificate, Building safety certificate and Water and Sanitation Certificate alongwith other essential documents during functioning of the school which shall be renewed from time to time as per norms”.
